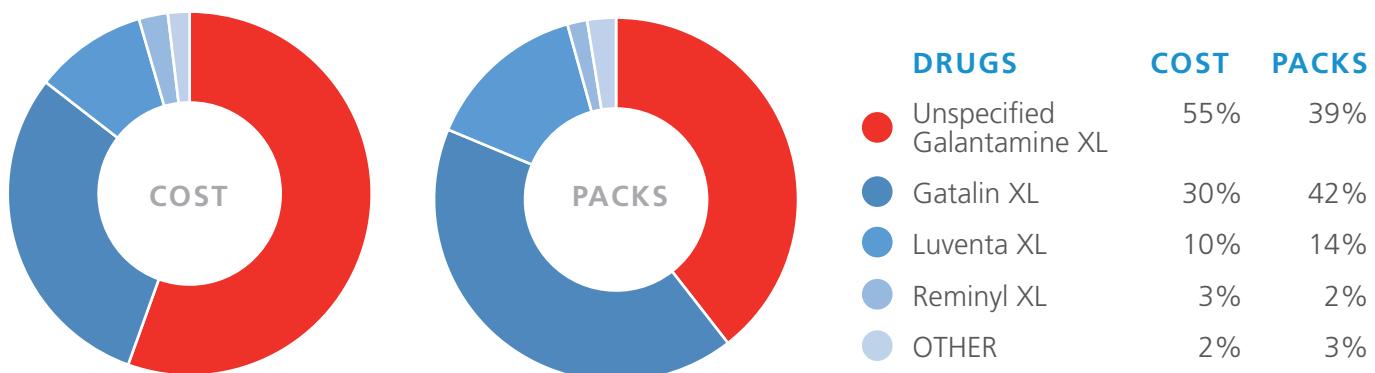

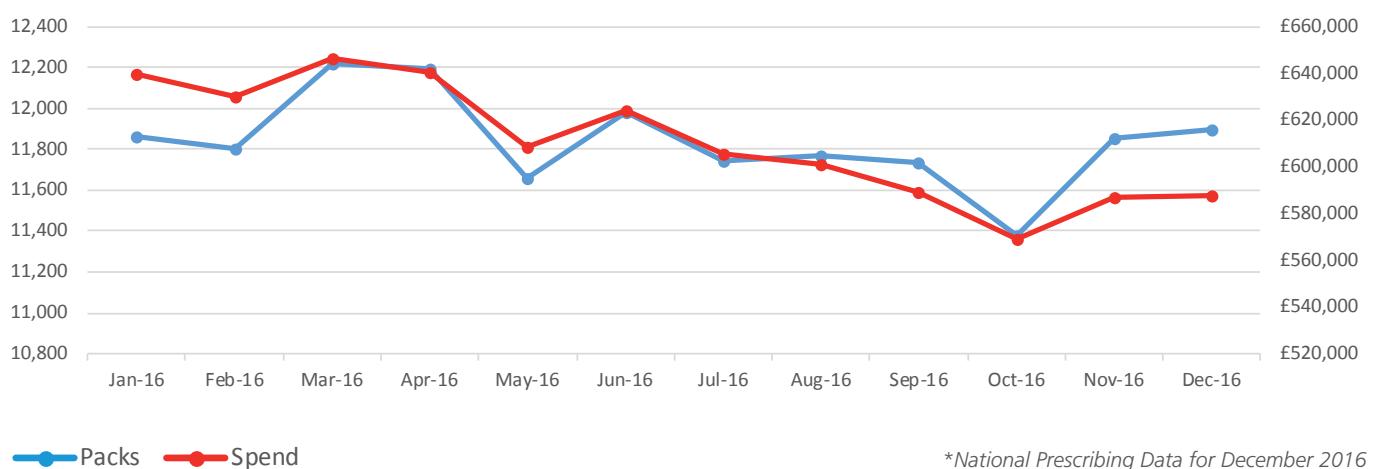

GALANTAMINE XL - NATIONAL SPEND / PACKS BY MONTH



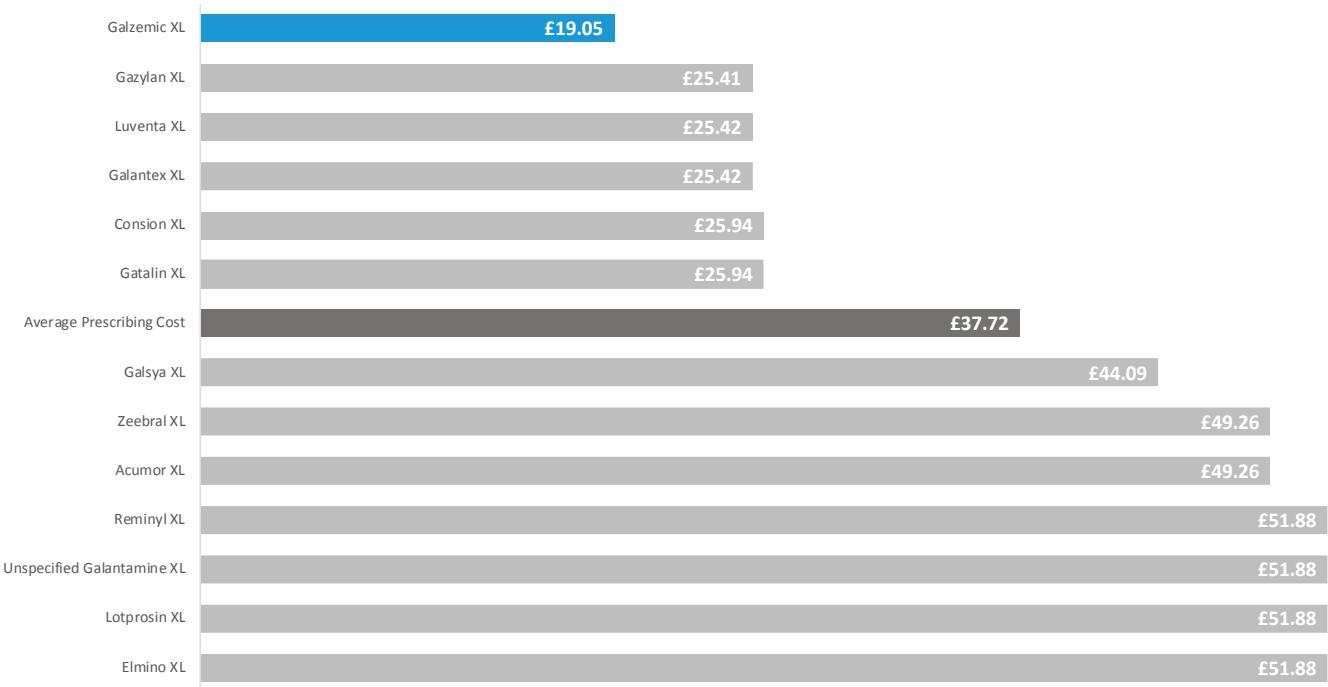
GALANTAMINE XL TOP PRODUCTS BY EXPENDITURE

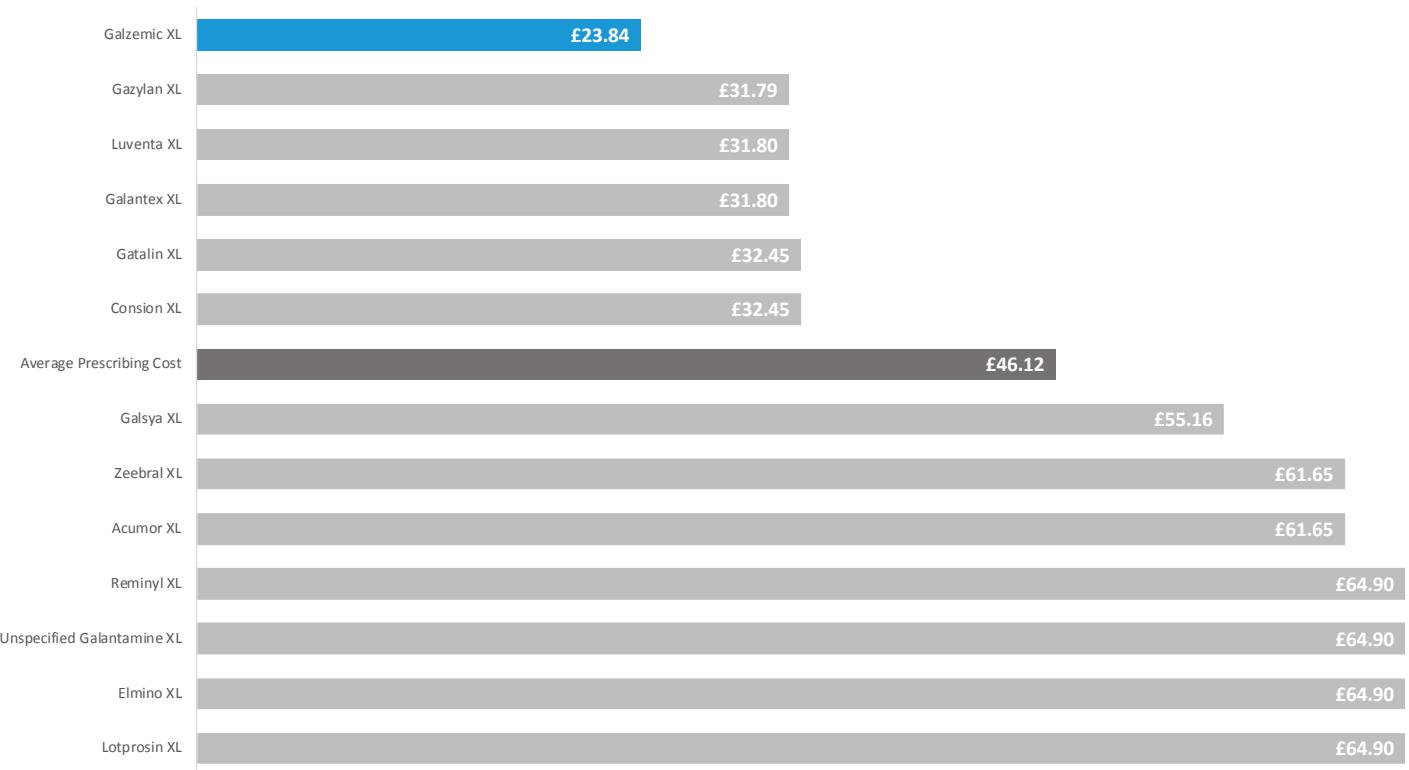

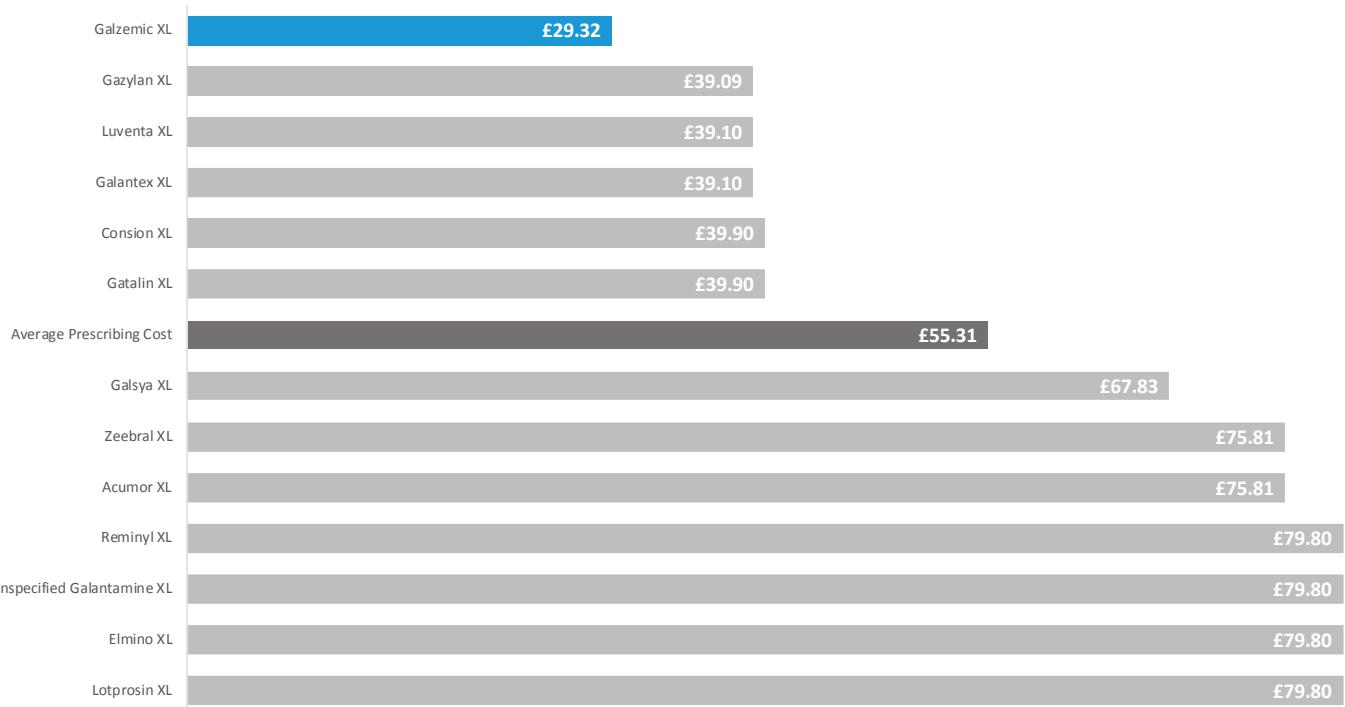
GALANTAMINE XL 8MG TARIFFS
